1. Establish list of visitors present who wish to address the Board/Hear from Public.

2. Discuss Hazard Mitigation Plan/Application Grant Applications, and drainage/flood mitigation matters and take actions related thereto.

3. Hear Auditor’s Report on water/wastewater revenue and take any action thereon.

4. Discuss information/format of bookkeeping report and take any action thereon.

5. Hear Delinquent Tax Attorney’s Report and take any action thereon.

6. Engineer’s Report, including: (a) report on status of construction projects and take action related thereto, including approval of pay estimates and change orders; (b) approve preparation of plans and specifications for District projects and authorize advertisement of bids relating thereto; (c) approve award of contracts for construction projects; (d) discuss capital projects plan and take action related thereto; and (e) discuss and take action on requests for service, including annexations.

7. Operations update and take action related thereto.

8. District Manager’s Report including: (a) report on District Management, Park operations, and approve expenditures related thereto; (b) approve amended Rules and Regulations for Park Facilities; (c) authorize purchase of equipment, inventory and supplies; (d) project status report, and (e) approve award of contract for facilities relating to parks and recreation.

9. Maintenance Manager’s Report including: (a) authorize purchase of equipment, inventory and supplies; (b) project status report, (c) approve award of contract for facilities, and (d) authorization of maintenance projects.

10. Personnel and Administrative Report including: (a) consider status of personnel, authorize pay increases, and hiring/termination of personnel; (b) approve changes to Employee Manual, and (c) conduct employee review.

11. Discuss and take action on trash contract.

12. Attorney’s Report, including approval of (1) Amended Rate Order, (2) Order Calling Director’s Election, (3) Joint Election Agreement with Harris County; and (4) appointment of Agent for Election Matters.

13. Discuss and take action on Drainage Policy.

14. Discuss and take action on Director Liaison/Committee Assignments and hear Liaison/Committee Reports and take any action thereon, including: (1) Flood mitigation; (2) Parks/Recreation; (3) Water/wastewater; (4) Solid Waste; (5) Administration/Personnel; and (6) Financial.

15. Discuss and take action on start time for future meetings.
