A. ANNEXATIONS

1. 2025 Annexations – TNRG Acquisitions (18.399 Acres).

The City of Houston (COH) Water District Consent Annexation Application has been submitted to the COH. COH is currently reviewing this application. LEI has updated the District's Metes & Bounds Description and Boundary Map; therefore, upon receipt of COH Approval, LEI will present these items for the board's execution.

B. WATER FACILITIES

1. Rehabilitation of Water Plant No. 1 (Series 2024 Bond Project No. XX)

LEI is currently producing an overall project scope and will provide the District with this scope upon completion and proceed with design. Currently, scope will include improvement to the Booster Pump Station, improvements to the Bolted and Welded Steel GST's (if needed), and improvements to the Hydropneumatic Tanks. Series 2024 Bond Funds will be used for this project.

2. TCEQ Sanitary Control Easement Request for Water Well No. 1 & Water Well No. 2

During the September meeting, the board executed the "Certificate for Order Establishing Rules and Regulations Regarding Sanitary and Pollution Control of the Areas in Proximity to the District's Public Water Supply Wells". LEI is currently preparing a formal response addressing all violations and providing all needed exceptions as requested by the TCEQ.

C. WASTEWATER FACILITIES

1. 2024 Clarifier Improvements (Series 2021 Bond Project No. 6)

As authorized by the Board during the March 2024 meeting, the District awarded subject project to Sustanite Support Services, LLC (S3) in the amount of \$1,083,000.00, replacing the existing Clarifier Mechanisms with in-kind equipment as provided by Ovivo. Project contracts were executed by the District during the April 2024 meeting. LEI released the Work Order (Notice to Proceed), for work to begin by Monday, May 6th, with completion of the project scheduled for Thursday, May 1st, 2025, that is 360 calendar days. **Currently, per S3, Ovivo noticed a defect on the produced center columns for both Clarifiers; therefore, Ovivo is producing new center columns, which are scheduled for shipping on 2/17. LEI has scheduled a Pre-Construction Meeting for 2/20, ahead of**

mobilization the week of 2/24. Attached for the boards review and consideration is Monthly Estimate No. 1 in the amount of \$230,214.70, to be paid to Sustanite Support Services, LLC.

2. 2025 WWTP Improvements – MCC Imp., Addition of Aerobic Digester & Thickener and Replacement of Automatic Bar Screen (Series 2021 Bond Project No. 1)

LEI has begun the design of this project and will begin preparation of plans, project contract documents, and Preliminary Engineer's of Probable Construction Cost.

3. 2022 Sanitary Sewer Rehabilitation Project (Series 2021 Bond Projects No. 15, 16 & 17)

Project is complete. On behalf of the District, LEI released the attached Completion Notice to the TCEQ. Currently, LEI is coordinating with HCED for full acceptance of the roadway pavement repairs done along Enchanted Oaks Drive, north of Cypresswood Dr. Upon acceptance, LEI will update the District.

4. WWTP Sluice Gate Replacements

During the March 2024 meeting, the Board executed project contracts with Neil Technical Services, LLC (NTS) to remove and replace six (6) sluice gates at the WWTP, in the amount of \$173,526.00, with a completion time of 90 calendar days upon delivery of these sluice gates. On March 26th, LEI authorized NTS to proceed with project submittals for LEI review and approval. Sluice gates were delivered to NTS the last week of January. Currently, LEI is coordinating with NTS to schedule a Pre-Construction Meeting to discuss the release of the Work Order (Notice to Proceed), and Project Schedule to prevent conflicts with the on-going Clarifier Imp. Project. Monthly Estimate No. 1 will be presented next week for the board's review and consideration. FURTHER DISCUSSION DURING MEETING.

D. DEVELOPERS

1. 18.38 Ac. Dev. at Meadowedge Ln & Hickory Twig Way – TNRG Acquisitions, LLC

During the May 2024 meeting, the Board approved granting subject development with 10,000 GPD of water and wastewater capacity following the completion of LEI's Feasibility Study and execution of the Utility Capacity Letter (UCL). Currently, LEI is reviewing the revised set of plans received from the Developer for subject private development, and discussing an Amendment to the Developer's Agreement with the District. Attached for the boards review and consideration is the Recommendation For Award for the District Project titled "Utilities to Serve 18 Ac. Tract at Meadowedge". LEI recommends this District project be awarded to Ram Rod Utilities, LLC in the total amount of \$490,940.49, with a contract time of 90 calendar days. Upon approval, LEI will produce a Notice of Award and Documents for Execution for the board's consideration at the March 11 meeting. FURTHER DISCUSSION DURING METING.



2. Spring Village State Venture – Various Tenants (20115 Holzwarth Rd)

During the July 2023 Meeting, the District granted 20,853 GPD of water and sewer capacity to subject development. LEI is currently conducting plan review for this proposed development for review and preparing plan comments.

3. Request for Service – Cypress Forest Sec. 1, Reserve B (14.35 Ac) Tract.

On Tuesday, January 7th, LEI received an Application for Service for New Development from Fidelis (the Developer), requesting 7,900 gpd of Water service and 18,400 gpd of Sewer service for a proposed Industrial Development, proposed within a 14.35 Ac. tract within the District's boundary. As authorized by the Board during last month's meeting, LEI produced a draft feasibility study, describing that the District has capacity to serve the proposed development. If there are no objections, LEI requests board authorization to execute the Utility Capacity Letter, granting the developer with the said capacity. FURTHER DISCUSSION DURING MEETIG.

4. Request for Service – Louetta Retail Shell Buildings (1.92 Ac Res. 'A' within Kings Village)

LEI received an Application for Service for New Development and fee for service for a proposed Retail Development within Reserve 'A', adjacent to the Kings Village Subdivision, which is requesting 1,300 gpd of water and sewer service. As authorized by the Board during the November 2024 meeting, LEI produced a draft feasibility study, describing that the District has capacity to serve the proposed development. If there are no objections, LEI requests board authorization to execute the Utility Capacity Letter, granting the developer with the said capacity. FURTHER DISCUSSION DURING MEETIG.

E. OTHER BUSINESS

1. HCFCD Regional Det. Pond (Senger Basin; K500-31-00-E002) Partnership Project LEI awaits the Draft Engineering Study of a Regional Detention and Drainage Facility Project to mitigate flooding within the District and surrounding area. LEI was notified that HCFCD is planning to begin this study.

2. District Detention Pond Inspections & Services

LEI has released Compliance/Non-Compliance Certificates and Inspection Reports to mostly all Detention Pond Owners/Representatives. Currently, LEI is coordinating with those Owners/Representatives that received Non-Compliance Certificates and scheduling inspections. Upon completion, LEI will produce a complete Detention Pond Report for the District's Records. Currently, the only detention Pond LEI has



not received a response from is from Louetta Village Apartments only. FURTHER DISCUSSION DURING MEETING.

3. 2021/2024 District Bond Projects Distribution Records

As authorized by the board during the January 2023 meeting, LEI continues to update the 2021 & 2024 Bond Series Distribution Records Sheet to help keep tract of funds used/distributed for subject 2021 & 2024 Bond Projects and will continue to update and provide to the board upon request.

4. Harris County Precinct 3 – Holzwarth Corridor Study/Constables Det. Pond Modification Request.

During the February 2024 meeting, the board authorized Harris County Precinct 3 (HCP3) to proceed with surveying/geotechnical investigations for subject project. On Monday, September 9th, LEI received the Drainage Impact Analysis Report for subject project and during the October 2024 meeting, the Board authorized HCP3 to produce an Interlocal Agreement for the District's review and consideration. **NO ACTION THIS MONTH.**

5. Cypress Forest Lakes Park Sinkhole

As authorized by the Board during last month's meeting, Gauge Engineering took over the design responsibility for the repair of subject sinkhole and storm sewer. LEI will continue to coordinate with Gauge Engineering and facilitate in any way possible. FURTHER DISCUSSION DURING MEETING.

6. Proposed SCADA Improvements at District Facilities

Project is complete. LEI will notify the TCEQ of project completion.

7. Records Request – NHCRWA 2025 Waterline Extension

LEI has coordinated with LAN (NHCRWA Engineer), regarding release of District Records for what appears to be the preliminary engineering phase for the proposed Waterline Extension that will provide surface water to Water Plant No. 2. LEI is awaiting a response from LAN before release of records.

8. Cypress Forest Lakes Storm Water Quality (SWQ) Permit Renewal

Attached for the District's records is the SWQ Permit Renewal for Cypress Forest Lakes. This permit will expire on 1/21/2026. No further action needed.

9. Capital Improvement Plan (CIP) Update

The rules which regulate the design, installation and testing of domestic wastewater projects are found in 30 TAC, Chapter 217, of the Texas Commission on Environmental Quality (TCEQ) rules titled, <u>Design Criteria for Wastewater Systems</u>.

Section 217.6(d), relating to case-by-case reviews, states in part that upon submittal of a summary transmittal letter, the executive director may approve of the project without reviewing a complete set of plans and specifications.

Under the authority of §217.6(e) a technical review of complete plans and specifications is not required. However, the project proposed in the summary transmittal letter is approved for construction. - Any deviations from Chapter 217 shall be disclosed in the summary transmittal letter and the technical justifications for those deviations shall be provided in the engineering report. Any deviations from Chapter 217 shall be based on the best professional judgement of the licensed professional engineer sealing the materials and the engineer's judgement that the design would not result in a threat to public health or the environment.
- Any variance from a Chapter 217 requirement disclosed in your summary transmittal letter is approved. If in the future, additional variances from the Chapter 217 requirements are desired for the project, each variance must be requested in writing by the design engineer. Then, the TCEQ will consider granting a written approval to the variance from the rules for the specific project and the specific circumstances.
- Within 60 days of the completion of construction, an appointed engineer shall notify both the Wastewater Permits Section of the TCEQ and the appropriate Region Office of the date of completion. The engineer shall also provide written certification that all construction, materials, and equipment were substantially in accordance with the approved project, the rules of the TCEQ, and any change orders filed with the TCEQ. All notifications, certifications, and change orders must include the signed and dated seal of a Professional Engineer licensed in the State of Texas.

This approval does not mean that future projects will be approved without a complete plans and specifications review. The TCEQ will provide a notification of intent to review whenever a project is to undergo a complete plans and specifications review.
