Any non-compliance with this Application or the District Rate Order will result in immediate termination of water service and pulling the meter for the service site. A non-compliance fee of **\$25 per day** will be applied until the application, application fee and Harris County approved plans have been submitted to and received by the District Manager. All applicable fees will apply for reinstallation of the meter and restoring service to the site After the application has been received and approved by the Water District, Applicant will be informed of the Approval/Disapproval of this application via written letter from the Water District Manager. All inspection services and fees in section 2.08 of the Rate Order may apply depending on the scope of the project in this Application.

UPON EXECUTION AND SUBMITTAL OF THIS APPLICATION, APPLIANT SHALL BE DEEMED TO BE GRANTING TO THE WATER DISTRICT AND ITS REPRESENTATIVES A RIGHT OF INGRESS AND EGRESS TO AND FROM THE METER OR POINT OF SERVICE FOR SUCH INSTALLATION, MAINTENANCE AND REPAIR AS THE DISTRICT, IN ITS JUDGMENT, MAY DEEM REASONABLY NECESSARY, AND SHALL ALSO BE DEEMED TO BE GRANTING TO THE DISTRICT AND ITS REPRESENTATIVES A RIGHT OF INGRESS AND EGRESS TO THE CUSTOMER'S PROPERTY, INCLUDING THE INTERIOR AND EXTERIOR OF THE CUSTOMER'S PREMISES, FOR THE PURPOSE OF PERFORMING INSPECTIONS REQUIRED BY THIS RATE ORDER, INCLUDING THE RULES AND REGULATIONS.
